I wish to apologize for not having written sooner. Your request was referred to me while I was away in New York and upon my return I have been so occupied with arrangements for forthcoming shows and a thousand other matters, I have had to defer answering you until today. I hope it is not too late.

The question of organizing a representation from the United States 1's a large one and involves many responsibilities. I wish we could talk about it instead of write. I suggest that you communicate at once with Richard Jaquish, Fine Photographs, 1054 Jenifer Street, Madison, Wisconsin, who has recently organized a service by which he rents original photographic prints to amateurs. I am sure he would be interested in assisting you and he could prepare an excellent showing of avant garde workers. Within the last three years what might be called a neo-realist movement (impelled largely by the important work of Robert Frank) has manifested itself and the show would be incomplete without including some of its protagonists. If you will allow me a few more days, I shall prepare a list of photographers, with addresses, which I believe will cover a tremendous activity, but only in a cursory manner. Meanwhile, write Nathan Lyons, Assistant Director, George Eastman House, 700 East Avenue, Rochester, 7, New York, ordering a copy of the Eastman catalogue, Photography at Mid-century, which is an excellent summary of present day work - with addresses included. Also, you might inquire of the Carl Siembab Callery, 172 Newberry Street, Boston, Massachusetts, as they might prepare a handsome group of prints for you.

Even with these few leads, I believe you can do much for your admirable effort. I shall have my list on the way by the middle of next week and again I apologize for the lateness of its arrival. I wish I could find time to write you a long account of our activities here and regret that you have not seen some of our exhibitions. If you ever come to Chicago, please get in touch with me as it would make me very happy to talk with you about this large and complicated subject with which we are involved.

Magnum (Cartier-Bresson's group) is of great importance and despite "avant-garde" activities all over this country, the avant-garde - just as in films - does not carry off all significance. So I hope you will give Magnum some thought. And I must add that avant-garde is well represented on the list.

I wish I could hear of what happens with youreffort. I am still sorry to have been late, but my curiosity is greatly aroused.
